#### **Approved Minutes**

The regular monthly meeting of the Manistee Township Board was held on Tuesday, January 19, 2021 at 7:00 P.M., at the Manistee Township Hall. Board members present were Supervisor Dennis Bjorkquist, Clerk Dianne Taylor, Treasurer Connie Jankwietz and Trustee Guy Finout. Also present were County Commissioner Jeff Dontz, Fire Chief Chuck Barron, Captain Sam Koscinski and Bob Meyers. Trustee John Dontz, Liquor Inspector Rick Clouse and Zoning Administrator Karen Clouse were absent.

Supervisor Dennis Bjorkquist called the meeting to order. All attending stood and opened with the pledge to the United States flag.

Minutes of the December 21, 2020 Manistee Township Board meeting were provided. Trustee Finout made the motion to approve the minutes as written, seconded by Treasurer Jankwietz. All in favor; motion carried.

Treasurer Jankwietz provided the Treasurer's report for the month of December 2020. The receipts were \$543,963.41; expenditures were \$521,993.61, leaving a balance of \$81,503.97 in the General Fund as of December. Treasurer's report was placed on file.

Clerk Taylor introduced Melanie Skory as a new office assistant.

There were no public comments at this time.

Manistee County Commissioner Jeff Dontz reported on activities. The County Treasurer's office is researching fee schedule changes, Bear Lake Township and Village of Onekama have contracted with Manistee County for Zoning Administration. Glen Zaring was appointed to the County Planning Commission; there is a vacancy on the Library Board. Dial-A-Ride is under contract for another year. Ariel map upgrades were discussed.

Trustee Finout, retired Zoning Administrator, reported on the activity in the Zoning office for December. There were no new complaints. There was one (1) land use permit issued and ten (10) requests for construction permits. The Zoning office is working on new forms for land use permits. Supervisor Bjorkquist thanked Trustee Finout for his 12 years of service to Manistee Township as Zoning Administrator.

Fire Chief Chuck Barron reported twelve (12) meetings and/or training sessions were held; twenty-eight (28) medical runs; four (4) fire runs. Trucks #131 has been on four (4) runs so far and performed well, #134 has minor maintenance work to be completed. All trucks are in good working order and expected to undergo annual DOT inspection soon. The department has been using the VP200ESK sanitizing sprayer on the trucks as well as equipment and building to prevent the possible spread of COVID. The Department received the 50/50 grant from the State for 2020 and is in the final stages of the 50/50 grant for 2021. The department was awarded two (2) Revenue Sharing Grants to purchase (1) a stokes basket and (2) a station generator. Training is ongoing.

In the absence of Liquor Inspector Rick Clouse, Supervisor Bjorkquist stated there were no violations or citations for the month of December.

Supervisor Bjorkquist gave a brief update on the township. The Bar Lake outlet deck holding well due to being sheet piled and concreted, and the M55 Bridge project is going as well as can be expected.

Trustee Finout made a motion to enter a contract with Manistee County for 2021 Tax Map and Assessment Services at \$4.09 per parcel; seconded by Clerk Taylor. All voted in favor; motion carried.

Trustee Finout made a motion to enter a contract with Manistee County for 2021 SET Summer Tax Collection at \$1.00 per parcel; seconded by Treasurer Jankwietz. All voted in favor; motion carried.

Treasurer Jankwietz made a motion to contract with Brown Township for Fire and Medical Protection in 2021; seconded by Trustee Finout. All voted in favor; motion carried.

Trustee Finout moved and was supported by Treasurer Jankwietz to adopt Resolution 2021-01 to Amend the Water Service Agreement between the Township of Manistee and the City of Manistee. **WHEREAS**, The Township of Manistee recognizes the need for the Fire Department to have sound working fire apparatus to protect the residents of the Township and surrounding areas when responding to fires; and,

**WHEREAS**, the current Manistee Township Fire Department cascade and compressor breathing air system used to fill the air bottles is obsolete; and,

**WHEREAS,** there may be funding available through the Assistance to Firefighters Grant (AFG) that would allow for the purchase of equipment to upgrade the current cascade and compressor breathing air system from 2216-psi to the 4,500-psi needed to fill the department's current air supply bottles; therefore,

**BE IT RESOLVED**, the Manistee Township Board approves the submission of an AFG grant application to upgrade the current Cascade and Compressor Breathing Air System at an estimated cost of \$34,290.00, of which the Township is responsible for five percent (5%), or \$1,714.50.
